*Whereas, vide this office Notice No. CEO/SPN/IMW/2814-19/- dated: 06/7/2022, Final Seniority list of CPWs/ LFWs of School Education Department, District Shopian as stood on 01/07/2021 was notified in print & electronic media; and*

*Whereas, Director School Education Kashmir, Srinagar's endorsement No. DSEK/IMW/VG-56/2020/1040-49 dated: 10/06/2022 an advisory from Anti Corruption Bureau J&K issued vide No. ACB-Edu-G-102-2019-212-14 dated: 06/01/2022 directed all the Chief Education Officers to examine the files of CPWs afresh, besides, maintain the proper record and ensure transparency in the process of regularization of CPWs henceforth; and*

*Whereas, Director School Education Kashmir, Srinagar vide letter No. DSEK/NT/DPC/CPW/All/3029-39 dated: 11/06/2022 issued instruction for processing of cases and conveying of meeting of DPC at an earliest; and*

*Whereas, the undersigned chaired a meeting of Departmental Promotion Committee constituted for the absorption of qualified & eligible CPWs/ LFWs of School Education Department as Class-IV employees on 25/06/2022 and it was decided by the DPC members to clear pendency of documents and observations that raised during the perusal of records/ files of CPWs before affecting their absorption/ regularization in the department in light of the advisory issued by higher authorities from time to time; and*

*Whereas, during verification process by DPC members, the D.O.B and Date of eligibility were found recorded inappropriately of some CPWs/LFWs due to omissions and errors; and*

*Whereas, the members of the committee scrutinized the general seniority list and submitted their report on 10/03/2023 for want of certain clarification/ pending documents, if any from the concerned CPWs/ LFWs.*

*Now, therefore, the list of CPWs/ LFWs, stood on 13/03/2023 is hereby issued as per Annexure 'A' to this notification on official website ([www.ceoshopian](http://www.ceoshopian)) for invitation of objections (if any) and clarification from the concerned candidates/ stakeholders. Any variation in the particulars/ clarification in the list shall reach to this office with documentary evidence as per observation raised and rooted through the respective DDO/ HOI(s) within a period of 07 days from the publication of this notification. After expiry of stipulated period no objection/ clarification will be entertained and accordingly this office will proceed to submit the Final seniority list to the Directorate of School Education Srinagar for conduct of meeting in respect of eligible CPWs for absorption as Class-IVs as per available vacancy of promotion quota.*

*Further, the mere figuring of CPW/LFW in the seniority list shall not entitle him/ her to the absorption / regularization in the department, which shall be subject to authenticity of genuineness of engagement order, wages, qualification, working & conduct certificate.*
