Whereas, several notices were served by the Department/Drawing & Disbursing officer/ Chief Education Officer concerned to these officials to explain their position for remaining un-authorizedly absent from their legitimate duties which did not evoke any response in writing or in person from these officials indicating therein their unwillingness to continue in the Department; and

Whereas, remaining un-authorizedly/continuously absent from legitimate duties by Government Servant attracts action as warranted in terms of Article 128 & 113 Of JKCSR Vol-I of 1956 which reads as:-

Article 128

"Absence without leave or after the end of leave involves loss of appointment".

Article 113

"After five years of continuous absence on leave an officer is considered to be out of state employee."

Now, therefore, through the medium of this notice, above mentioned officials are asked to explain as to why action as warranted under Article (128) and Article (113) of J&KCSR Vol-I of 1956 (whichever applicable) to them shall not be taken against them. The official shall present themselves before this Directorate along with written statement of defense within a period of 15 days from the date of issuance of the notice, failing which it shall be construed that they have nothing to say in their defense and action as warranted under relevant rules shall be initiated against them without any further notice.
