Sanction is hereby accorded to the grant of Promotion In-Situ to the Higher Standard Pay Scale in terms of J&K Civil Services (Higher Standard Pay Scheme) Rules 1996 issued by J&K Government vide SRO-14 Dated: 15/01/1996 in favour of [07] Grade-II Teachers, cleared by the District Level Committee under the Chairmanship of Chief Education Officer Shopian and a member from Directorate of School Education Kashmir in the DPC held on 13/08/2020, nominated by DSEK vide Circular No. 121-DSEK of 2020 Dated: 27/02/2020, in the pay band with grade pay from the date as indicated against each in the Annexure(A) to this order. However the monetary benefit on account of In-situ promotion shall be restricted to maximum of three years, in terms of rules 2.43 of Financial Code Vol-I.

The In-Situ Promotion arrears of officials shall not be drawn till additional funds for the specific purpose are released by the Competent authority (except retired officials) for which the concerned DDO's shall figure out the provision and submit the requisition accordingly in consolidated manner to the Directorate for adopted Budget 2019-20. Deviation if any shall warrant strict disciplinary action against DDO

The particulars of these officials in whose favour the time bound promotion is being granted/released are shown in the Annexure(s) to this order.

The Promotion In-Situ to the Higher Standard Pay Scale in favour of teaching officials is granted /released subject to the fulfillment of the following conditions and the DDO concerned will personally verify the original service records of each RRT and ensure that:-

The RRTs have completed five years of honorarium service on the date indicated against each in the annexure to the order and have not availed any kind of leave whatsoever which does not count for service benefits for regularization in terms of Government order No. 549-Edu of 2005

That the DDO before implementing the order shall once against re-verify the due date of regularization of each RRT after going through service

That the RRTs were not on rolls of any institution/university during the honorarium service/after regularization service and have not acquired any higher qualification as regular candidate in case, if it has been detected while verifying the service records, that any of the RRT have acquired higher qualification during honorarium/ regularization service as a regular candidate. The order in favour of such RRT should not be endorsed by

That in case of Degrees acquired through Distance/ Private mode during honorarium/regular service, the same shall be reflected in the original

That the DDO will personally seek authentication of certificates both from the Distance and Regular Mode, from the issuing authorities.

That the DDO concerned will ensure/ satisfy himself that the particulars of RRT are correct according to the documents and the initial engagement as ReT/Regularization of each incumbent has been made by the competent authority and are genuine/ correct before implementing

That the time bound benefit shall be treated as forfeited without issuance of further order, if any stage it is found that the Degree certificates accounted for, are fake and have been obtained through tuck shops/un-recognized Universities /institutions the benefit shall be cancelled

That the Time Bound cases are not against any Court direction/ instructions given by the Hon'ble Court.

That the DDO will be personally responsible for the genuineness, legality and eligibility of the concerned employees viz-a-viz their initial engagement /regularization their degree from the Recognized Universities and Time Bound Promotion.

That recovery of excess pay and allowance, if any pointed out shall be attended on priority while payment of arrears on a/c of In-situ promotion. That the RRT has availed leave under rules for the purpose of higher studies which has been conveyed this office at the time of regularization.

That the degree(s) have been acquired in terms of circular instructions governing the issue of improving of qualification during honorarium That the degree (if any) has been acquired through Recognized Board/University/College.

That the DDO shall be personally responsible for genuineness/legality and validity of the certificate.

That the ReTs have only availed leaves which were due to them under rules and excess leave, if any, have been accounted for at the time of

That there are no criminal cases proceedings pending against the official(s) before any investigating agency viz. (VOK/ Crime branch/ etc.) or court of law and the genuineness of appointment has been ascertained / established in respect of the employee(s). That the DDO concerned will follow all codal formalities before making fixation or releasing the arrears of in-situ promotion.
