As approved by Departmental Promotion committee constituted vide Director, School Education Kashmir's Order No. 403-DSEK of 2021 Dated: 12/07/2021 issued vide No. DSEK/NT/DPC/CPWS/1071-80, Dated:- 12/07/2021 read with addendum issued vide No. DSEK/NT/DPC/2021/All/1185-90 Dated: 28/07/2021, in its meeting held on 08/06/2024 and receipt of satisfactory Character and Antecedents report from Criminal Investigation Department, J&K, sanction is hereby accorded to the regularization/ absorption of Thirty Two (32) Contingent/ Local Fund Paid Worker as Class-IV (MTS) in terms of SRO-308 dated:- 16/10/2008 (The Jammu and Kashmir School Education Department (Subordinate) Services Recruitment rules, 2008) in the School Education Department, District Cadre Shopian forming "**Annexure -A**" to this Order in the Pay Level SL1 (14800-47100) on available promotion quota vacancies with immediate effect.

The regularization/ absorption are subject to the fulfillment of following explicit conditions:-

1. That the regularization shall be without prejudice to the final outcome of the case(s), if any sub-judice/ impugned or pending before the Hon'ble High Court/CAT or any other court and other orders, if any passed by the competent authority, which may not be immediately in the knowledge of this office.
2. That the Contingent/ Local Fund Paid Worker(s) must necessarily be physically working since their engagement (uninterrupted service). The regularization shall not be allowed in case of Contingent/ Local Fund Paid Worker(s) whose work and conduct is not satisfactory.
3. That the concerned DDO's shall check the Acquittance, wages drawal statement of each Contingent/ Local Fund Paid Worker(s) before allowing them to join.
4. That the Contingent/ Local Fund Paid Worker(s) will furnish an undertaking duly sworn in before the 1st Class Judicial Magistrate to the effect that if on subsequent verification of his/her initial engagement as CPW/LFW, wages drawal statement, qualification certificates and other credentials are found fake/ fabricated, the appointment/absorption shall be terminated *ab-initio* without any further notice and action shall be taken as per rules.
5. That the regularized Contingent/ Local Fund Paid Worker(s) as Class-IV (MTS) are required to report to Chief Education Office, Shopian within 21-days from the date of issuance of this order, failing which the Order shall automatically be deemed to have been rescinded *ab-initio* in his/her favour without issuing formal cancellation orders.

6. That the inter-se seniority shall be issued in accordance with the relevant rules and as per the seniority of the regularized Official from seniority position in the final CPW/LFW Seniority list.
7. The DDO's shall in no case draw the salary in favour of the appointees/absorbed CPWs without verification of the following credentials.
 - a. *Initial engagement Order (Original)*
 - b. *Qualification certificate(s) (Middle pass or above) in original and its verification from the competent issuing authority.*
 - c. *Wages drawn statement from the DDO concerned from the date of initial engagement duly authenticated or a certificate from the DDO concerned that he/she has been drawing his/her wages continuously from the date of his/her initial engagement.*
 - d. *A certificate from the DDO concerned that the Contingent/Local Fund Paid Worker is presently working and his service is un-interrupted.*
 - e. *Birth certificate issued by the competent authority.*
 - f. *Physical/ Mental fitness certificate issued by the competent Medical Officer/ authority.*
 - g. *Certificate from General Manager, DIC concerned and Deputy Director Employment concerned to the effect that no loan has been taken by the candidate under any scheme.*
8. The appointees shall be governed under New Pension Scheme as per SRO-400 of 2009 dated:- 24.12.2009 and shall be on probation for a period of two (02) years.
9. That the DDO concerned shall verify the particulars as mentioned above to this Order and in case of any discrepancy, and same shall be communicated to this Office immediately, and such Contingent/ Local Fund Paid Worker(s) to join his/her Office/ School.
10. The formal adjustment/posting orders in case of these regularised officials shall be issued separately.
