Subject:- Regularization/ absorption of CPW/LFW as Class-IV in the School Education Department, District cadre Shopian

**ORDER NO. 03 - CEOSPN OF 2025**

**DATED:- 25 -01-2025**

Whereas, the meeting of Departmental Promotion Committee for the promotion of qualified CPWs/LFWs of District Shopian as MTS was held in this office on 08/06/2024 and among other decisions the DPC observed that the case of one Mr. Aijaz Ahmad Khan S/o Gh Mohd Khan R/o Shadab Karewa working as CPW at HS K.Manloo be kept pending subject to the final outcome of civil suit titled Aijaz Ahmad Khan Vs UT of J&K & Ors; and

Whereas, the case of the CPW/LFW was re-examined in view of suit pending at Hon'ble District Court Shopian after obtaining fresh verification/genuineness of 1st Appointment order and was placed before the designated committee for appropriate decision on the merits; and

Whereas, the committee after threadbare discussion approved the case of Mr Aijaz Ahmad Khan S/o Gh Mohd Khan R/o Shadab Karewa CPW HS Shadab Karewa for absorption/regularization as Class-IV (MTS) in School Education Department on available promotion quota vacancy, subject to the withdrawal of civil suit titled Aijaz Ahmad Khan Vs UT of J&K & Ors; and

Whereas, Mr. Aijaz Ahmad Khan S/o Gh Mohd Khan R/o Shadab Karewa, CPW has withdrawn the suit application from the Hon'ble District Court Shopian in the Case titled Aijaz Ahmad Khan Vs UT of J&K & Ors and the same has been disposed off on 06/12/2024 as uncontested-withdrawn (CNR Number JKSP020006582023); and

Whereas, satisfactory report of character and antecedents (Form No.119938) from CID J&K in favour of Mr. Aijaz Ahmad Khan S/o Gh Mohd Khan R/o Shadab Karewa CPW HS Shadab has already been received by this office; and

Whereas, this office published a notification in print/electronic media vide No.CEO/SPN/Estt/NT/628-34 dated 13/01/2025 which appeared in the daily newspaper "Srinagar Times" dated 15/01/2024 (DIPK NO:10828/24 dated 14/1) for the information of general public/stakeholders for invitation of objections, if any, regarding the proposed regularization/absorption of Mr. Aijaz Ahmad Khan S/o Gh Mohd Khan R/o Shadab Karewa CPW HS Shadab Karewa with documentary evidence: and

Whereas, this office has not received any objection regarding the proposed regularization/absorption of Mr. Aijaz Ahmad Khan S/o Gh Mohd Khan R/o Shadab Karewa CPW HS Shadab Karewa within the prescribed stipulated time period; and

Now, therefore pursuant to the decision of Departmental Promotion Committee (DPC) and receipt of satisfactory character and antecedents report from Criminal Investigation Department (CID) JandK, Sanction is hereby accorded to the regularization/ absorption of following Contingent/ Local Fund Paid Worker as Class-IV (MTS) in terms SRO-308 dated:- 16/10/2008 in the School Education Department (Subordinate) Service in District Cadre Shopian in the Pay Level SL1 (14800-47100) on available promotion quota vacancy(s) with immediate effect.

The regularization/ absorption are subject to the fulfillment of following explicit conditions:-

1. That the regularization shall be without prejudice to the final outcome of the case(s), if any sub-judice/ impugned or pending before the Hon'ble High Court/ CAT or any other court and other orders, if any passed by the competent authority, which may not be immediately in the knowledge of this office.

2. That the Contingent/ Local Fund Paid Worker(s) must necessarily be physically working since their engagement (uninterrupted service). The regularization shall not be allowed in case of Contingent/ Local Fund Paid Worker(s) whose work and conduct is not satisfactory.
3. That the concerned DDO's shall check the Acquittance, wages drawal statement of each Contingent/ Local Fund Paid Worker(s) before allowing them to join.
4. That the Contingent/ Local Fund Paid Worker(s) will furnish an undertaking duly sworn in before the 1<sup>st</sup> Class Judicial Magistrate to the effect that if on subsequent verification of his/her initial engagement as CPW/LFW, wages drawal statement, qualification certificates and other credentials are found fake/ fabricated, the appointment/absorption shall be terminated *ab-initio* without any further notice and action shall be taken as per rules.
5. That the regularized Contingent/ Local Fund Paid Worker(s) as Class-IV (MTS) are required to report to Chief Education Office, Shopian within 21-days from the date of issuance of this order, failing which the Order shall automatically be deemed to have been rescinded *ab-initio* in his/her favour without issuing formal cancellation orders.
6. That the inter se-seniority shall be issued in accordance with the relevant rules and as per the seniority of the regularized Official from seniority position in the final CPW/LFW Seniority list.
7. The DDO's shall in no case draw the salary in favour of the appointees/absorbed CPWs without verification of the following credentials.
  - a. *Initial engagement Order (Original)*
  - b. *Qualification certificate(s) (Middle pass or above) in original and its verification from the competent issuing authority.*
  - c. *Wages drawn statement from the DDO concerned from the date of initial engagement duly authenticated or a certificate from the DDO concerned that he/she has been drawing his/her wages continuously from the date of his/her initial engagement.*
  - d. *A certificate from the DDO concerned that the Contingent/Local Fund Paid Worker is presently working and his service is un-interrupted.*
  - e. *Birth certificate issued by the competent authority.*
  - f. *Physical/ Mental fitness certificate issued by the competent Medical Officer/ authority.*
  - g. *Certificate from General Manager, DIC concerned and Deputy Director Employment concerned to the effect that no loan has been taken by the candidate under any scheme.*
8. The appointees shall be governed under New Pension Scheme as per SRO-400 of 2009 dated:- 24.12.2009 and shall be on probation for a period of two (02) years.
9. That the DDO concerned shall verify the particulars as mentioned in "TABLE - A" above and in case of any discrepancy, the same shall be communicated to this Office immediately.
10. The formal adjustment/posting orders in case of these regularised officials shall be issued separately.
