Subject:- Tentative Seniority List of CPWs/ LFWs of School Education Department, District Shopian for invitation of objections/ clarifications – Regarding

NOTIFICATION

Whereas, the Final Seniority List of CPWs/ LFWs of District Shopian was issued by this office vide Notification No. CEO/SPN/Estt/NT/3610-18 dated 18.08.2023; and

Whereas, 39 CPWs/LFWs regularized during the year 2024–2025 and one (01) CPW who has resigned have been excluded from the seniority list; certain CPWs/LFWs have crossed the upper age limit prescribed for appointment as Government servants; and certain CPWs/LFWs, from the initiation of verification by the District Level Committee(s), have failed to clear the observations and have accordingly been placed in their respective Annexures; and

Whereas, various objections/ representations supported by relevant documents were received by this office from CPWs/ LFWs, seeking rectification of their official records; and

Whereas, to address these grievances, a Public Notice vide No. CEO/SPN/Estt/NT/15541-15604 dated 10.10.2025 was issued inviting objections/ representations from concerned CPWs/ LFWs within a period of 21 days; and

Whereas, upon expiry of the said period, a final opportunity was granted vide Notification No. CEO/SPN/Estt/NT/25/17801-08 dated 20.12.2025 for submission of pending documents/ testimonials within 07 days; and

Whereas, the documents/ representations so received were placed before the District Level Committee constituted vide Order No. 33-CEO(SPN) of 2025 dated 10.10.2025 for scrutiny and verification; and

Whereas, the District Level Committee, after thorough scrutiny, recorded deficiencies/ observations in various cases, including issues relating to verification/ authentication of Engagement Orders, verification of qualification certificates (including cases pertaining to gutted institutions requiring verification under Government Order No. 07-JK-(Edu) of 2023 dated 05.01.2023 followed by DSEK Communication No. DSEK-NTS/415/2024/959-69 dated 15.05.2025), non-submission or incomplete wages statements, mismatch of official seals/ signatures, engagement by non-competent authority, and other document-related discrepancies; and

Whereas, the remaining CPWs/ LFWs, after exclusion of the aforesaid (39) and (01) CPW, have been categorized on the basis of their verification status and placed in Annexure "A" (Cleared Cases), Annexure "B" (Pending/ Deficit Cases), Annexure "C" (Ineligible Cases), and Annexure "D" (Unqualified Cases); and


Whereas, this notification is issued without prejudice to the Court cases, if any pending in the Hon'ble Court which are not immediately within the knowledge of this office.

Now, therefore, the Tentative Seniority List of CPWs/ LFWs of District Shopian is hereby notified along with Annexure "A", "B", "C", and "D" for information of all concerned stakeholders.

All CPWs/ LFWs whose cases are reflected in the tentative seniority list are hereby called upon to submit their objections/ clarifications (if any) along with requisite supporting documents, duly attested by the concerned DDOs, to this office within 07 (seven) days from the date of publication of this notification. Failure to comply within the stipulated time shall result in the cases remaining in the same Annexure, and no claim/ objection shall be entertained thereafter.

Further, the District Level Committee shall proceed with physical verification of records in respect of such CPWs/ LFWs where it deems necessary, as well as in cases where physical verification has been specifically indicated in the Remarks column, and shall submit its report/ recommendations to this office for further course of action.
